## HCTC Achieves Division Status



### Welcome to HCTD!

At last our NCA Human Communication and Technology Commission (HCTC) has matured from a Commission to become a Division. On November 24, 2002, during our National Communication Association New Orleans Convention, the NCA Legislative Council voted to grant HCTC status as an NCA Division. Our official name is now the Human Communication and Technology Division (HCTD). This promotion in rank will give HCTD the opportunity to have a strong voice as well as a vote at future NCA Legislative Council meetings and a vote on the NCA nominating committee.

We owe our Division status to you our HCTD members—thank you for your interest in HCTD. In order to qualify for NCA Division status, we needed to reach the 300 membership mark for two consecutive years. We are excited to inform you that we not only met but exceeded the 300 membership mark for two consecutive years. In fact, on

November 24, 2002, HCTD had over 400 members!



HCTD is grateful to its founding, past, and present officers. Without their tireless efforts, there would not be a HCTD today. Now that we have Division status, retiring Co-Chairs will serve a fifth year as NCA/HCTD representatives on the NCA Legislative Council meetings and on the NCA nominating committee. **Call to Order**

Frank Dance called the meeting to order at 5:00 p.m.

**II. Presidents Report**

Frank Dance and Karen Lollar, President Co-Chairs, gave the report about the Division Status of the Commission.

Frank Dance announced that, based on the current changes NCA is exploring in relation to its constitution, HCTC meets the requirements to be changed into a Division.

HCTC has over 400 members and accordingly needs to be considered a division.

HCTC members are encouraged to read about all the changes to the new constitution and to take note of the additional information posted on NCA's website.

After Frank Dance and Karen Lollar's report, Dennis Wignall and Tasha Van Horn took over as Co-Chair Presidents for 2002/3. Discussion on the co-Chair strategy, initiated by Dennis Wignall and Tasha Van Horn followed. There was a reiteration of the benefits of co-chairing partnership as a system of shared responsibility, teamwork, and leadership assistance for HCTC members. All members present favored the system. Dennis moved for HCTC to continue its strategy of having two co-chairing officers per president, planning, publication, membership and student representative. Scott D'Urso seconded the motion. Voted unanimously.

**III Program Report**

The report was given by Tasha Van Horn and Dennis Wignall.

Number of papers received: 74, with 53 accepted for panel presentation, and 9 for poster session inclusion, all within the 85% limit.

Number of complete panel submissions: 28, with 25 accepted.

Number of papers/panelists represented, not included in miscellaneous papers: 130.

HCTC shared co-sponsorship of 5 panels.

Reviewers: 17.

Copies of all panels accepted circulated among members.

Total of both panel paper presentations and discussion panels: 35

**IV Publication Report**

Report given by J.D. Wallace and Lori Charron

Two Newsletters produced over the 2001/2002 year, the second posted also via email to HCTC members.

Discussion about the Newsletter content, about including announcements about other calls for papers pertinent to HCTC, and call for feedback in order to reassert HCTC specific focus in the field of communication studies.

There was a suggestion [Dennis Wignall] followed by discussion on a mission statement articulating more the continued research and focus on the relationship between technology and theory-driven communication practices.

## **V Membership and Recruitment**

Report given by Noemi Marin.

Mary Wiemann and Noemi Marin created a call for renewal of membership and recruitment, posted and distributed in hard copy throughout the convention halls. In addition, the call was posted via email to all HCTC members. They approached graduate directors of certain programs to inform them about HCTC and foster membership/recruitment from the graduate student body.

Mary Wiemann and Noemi Marin created a Distribution List updating all the records about NCA HCTC members. Noemi Marin reported that there was a 20% return of the newsletter and of the call for membership due to inaccurate email addresses.

Having the electronic data stored, Noemi Marin announced that a HCTC Listserv is available at her institution.

Discussion followed on the challenges to have an electronic presence with a University that assures stability and continuous access to the information on HCTC. While the Listserv remains an important distribution tool, Dennis Wignall suggested to investigate more and make an informed decision on where to place the Listserv in order to be beneficial for all HCTC members over a long period of time.

## **VII HCTD Officers for next year**

The following people were nominated: Scott D'Urso, Andy Finn, Davis Foulger, Rodney Marshall, and A.J. Baltes. Voting for the Recruitment and Membership Co-Chairs took place. Elected: Andrew Finn and Davis Foulger. Voting for Student Representative position also took place. Scott D'Urso nominated Steve Rains and Kerk Kee nominated himself.

Before the vote, Tasha Van Horn articulated the need to have a co-chaired position for the student representative. Seconded by Rodney Marshall, voted unanimously.

Elected: Steve Rains and Kerk Kee as Co-Chairs Student Representative.

Andy had a previous career at AT&T, working on communication and information technologies from a variety of perspectives, including user interface and system design, technology implementation and training, voice mail product management, and voice processing product line planning. He has a B.S. in Mathematics from St. John Fisher College (Rochester, N.Y.), and a Ph.D. in Social Psychology from Washington University (St. Louis). Prior to coming to the George Mason in 2000 he taught at the University of Kentucky, Rutgers University, New York University, and Washington University in St. Louis.

Dr. Finn has two grown sons and currently lives what he calls the "sweet life" in Burke, VA, surrounded by his cats and friends.
